Dear Prospective Resolution Applicant,

The Resolution Professional (“RP”) of Natems Sugar Private Limited (“Corporate Debtor”), in discharge of duties under Section 25(2)(h) of the Insolvency and Bankruptcy Code, 2016 (“Code”) read with Regulation 36A of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 (“CIRP Regulations”), had published Form G on April 11, 2026 which was subsequently extended and republished on 29.04.2026, and thereafter further extended and republished on 15.05.2026, inviting Expressions of Interest (“EOIs”) from prospective resolution applicants (“PRAs”) for submission of resolution plans in respect of the Corporate Debtor.

The said publication was made in Financial Express – Pan India, Mana Telangana – Telangana Edition and in Praja Shakti – Andhra Pradesh Edition. The last date for submission of EOIs was 18:00 hours on 23rd May, 2026.

The RP, after evaluating the EOIs received from the PRAs and verifying that they fulfilled the minimum eligibility and qualification criteria as set out in Form G, identified such PRAs who are eligible to participate in the resolution plan process for the Corporate Debtor. Pursuant to such evaluation, a Provisional List of PRAs was issued in accordance with Regulation 36A (10) of the CIRP Regulations by the RP on 27th May, 2026.

Pursuant thereto, and considering that no objections were received with respect to the Provisional List of PRAs published by the RP, and in accordance with the provisions of Regulation 36A (12) of the CIRP Regulations, as well as the Form G issued by the RP, the RP hereby issues the final list of PRAs, as enclosed herewith.

Notes:

- The eligibility of the PRAs has been determined in accordance with the eligibility criteria specified in the Invitation for EOI and based on the due diligence undertaken by the RP on the basis of material and information available on record, as required under Regulation 36A of the CIRP Regulations.
- RP sought additional documents from Shri Lakshmi Enterprises, as the documents submitted were incomplete. Accordingly, Shri Lakshmi Enterprises shall be considered for inclusion in the final list of PRAs only upon submission of the requisite documents and subsequent verification and confirmation of its eligibility on or before 12.06.2026.
- In case the RP/ CoC subsequently become aware or are made aware of any facts and circumstances which may render any of the PRAs disqualified / ineligible to submit a resolution plan in respect of the Corporate Debtor (including but not limited to under Section 29A of the Code), in such case the RP/ CoC shall have the right to disqualify such PRA from the resolution plan process at any stage at their sole discretion.
- Pursuant to Regulation 36B of the CIRP Regulations, the PRAs included in the Final List are hereby requested to submit their Resolution Plans in accordance with the terms of the Request for Resolution Plan (“RFRP”), the Code, and the applicable regulations thereunder, to the RP within the timelines prescribed.
